#### **Special Instructions**

1. The acceptance and registration of applications for the examinations is Provisional. Admission to examination is subject to students, fulfilling all other criteria prescribed including eligibility for admission and attendance.
2. It is to be noted that remitting fee and submitting examination application is mandatory for students seeking promotion to next academic year 2018 -19 if eligible otherwise.

3. For students belonging to categories 2(a), 2(b), 3(a), 3(b) with annual income of not more than Rs.1,00,000/- exemption from remittance of Examination fee payable and extended to Fresher's Only and not available for Repeater batch students. Consequently, Repeater batch students are required to remit fee as applicable.
4. Payment of examination Fee is not a guarantee that student will be allowed to write the examination. A student will be allowed to write the examination only if:
  - Student should have required minimum attendance percentage for each course at the end of the semester.
  - Principal/Management should be satisfied with the general behavior of the student.
