Note: As per the KSLU guidelines * indicates that this particular fee is not applicable to candidates under SC/ST/Category — I with annual income of not more than Rs.2,50,000/- (only Regular semester examination fee and **not for Repeater batch students**). Such students should apply to get the reimbursement and submit the amount to the college within the stipulated date mentioned in the KSLU guidelines.

Repeaters Fee:

- Rs.255 for 1 paper + Appl form fee of Rs.120 and Marks card fee of 190 = 565
- Rs.600 for 2 papers + Appl form fee of Rs.120 and Marks card fee of 190 = 910
- Rs.810 for 3 papers + Appl form fee of Rs.120 and Marks card fee of 190 = 1120
- Rs.1055 for 4 Papers or more + Appl form fee of Rs.120 and Marks card fee of 190=1365

After paying the examination fee student should submit the fee paid receipt to the law office to updated the KSLU application form.

- The acceptance and registration of applications for the examination is provisional. Admission to examination is subject to students fulfilling all eligibility criteria to write examination, including eligibility for admission approval and promotion.
- > Student should have required minimum attendance for each course at the end of the semester
- ➤ Principal / Management should be satisfied with the general behavior of the student.

Students who do not apply for the end semester examination by paying the examination fee will not be eligible for promotion to the next semester.
